The above petition has been approved. The petition indicates that the person for whom you are petitioning is in the United States and will apply for adjustment of status. He or she should file Form I-485, Application to Register Permanent Residence or Adjust Status. A copy of this notice should be submitted with the petition with Form I-485. It is served as an attorney. If the person for whom you are petitioning decides to apply for a visa outside the United States, based upon the petition, the petitioner should file Form I-824, Application for Action in an Approved Application for Petition. It is requested that the petitioner send the petition to the Department of State National Visa Center (NVC).

The NVC processes all approved immigrant visa petitions that require consular action. The NVC also determines which consular post is the appropriate consulate to complete visa processing. It will then forward the approved petition to that consulate.

The approval of this visa petition does not in itself grant any immigration status and does not guarantee that the alien beneficiary will subsequently be found to be eligible for a visa, for admission to the United States, or for an extension, change, or adjustment of status.
