The above petition has been approved. We have sent it to the Department of State National Visa Center (NVC), 32 Rochester Avenue, Portsmouth, NH 03801-2909. NVC processes all approved immigrant visa petitions that need consular action. It also determines which consular post is the appropriate consulate to complete visa processing. The NVC will then forward the approved petition to that consulate.

This completes all USCIS action on the petition. You should allow approximately 120 days for Department of State processing before contacting the NVC. The approval of this visa petition does not in itself guarantee that you will be eligible for the alien benefit you are currently being denied to be eligible for a visa, for admission to the United States, or for an extension, change, or adjustment of status.
