The NVC will contact the person for whom you are petitioning concerning further immigrant visa processing steps.

The approval of this visa petition does not in itself grant any immigration status, and does not guarantee that the alien beneficiary will subsequently be found to be eligible for a visa or admission to the United States or for an extension, change, or adjustment of status.
