The above petition has been approved. We have sent a cable to the consulate listed above to notify them of the approval of the petition. We have sent the petition to the **Department of State National Visa Center (NVC), 32 Rochester Avenue, Portsmouth, NH 03801-2909.**

The NVC will contact the person for whom you are petitioning to examine if they are eligible for an immigrant visa process. The approval of this visa petition does not in itself grant any immigration status and does not guarantee that the alien beneficiary will subsequently be found to be eligible for a visa, for admission to the United States, or for an extension, change, or adjustment of status.
