The above petition has been approved. We have sent it to the Department of State National Visa Center (NVC), 32 Roosevelt Avenue, Portsmouth, NH 03801-2909. NVC processes and approves immigrant visa petitions that need consular action. It also determines which consulate post is the appropriate consulate to complete visa processing. The NVC will then forward the approved petition to that consulate.
