The above petition has been approved. We have sent it to the **Department of State National Visa Center (NVC)**, 32 Rochester Avenue, Portsmouth, NH 03801-2909. The NVC will then forward the approved petition to that consulate.

The approval of this visa petition does not in itself grant any immigration status and does not guarantee that the alien beneficiary will subsequently be found to be eligible for a visa, for admission to the United States, or for an extension, change, or adjustment of status.
