The above petition has been approved. We have sent it to the **Department of State National Visa Center (NVC)**, 32 Rochester Avenue, Portsmouth, NH 03801-2909. NVC processes all approved immigrant visa petitions that need consular action. It also determines which consular post is the appropriate consulate to complete visa processing. The NVC will then forward the approved petition to that consulate.

This completes all USCIS action on the petition. You should follow up within 30 days for Department of State processing before contacting the NVC. The NVC will contact the person for whom you are petitioning once they begin their immigrant visa processing steps. The approval of this visa petition does not in itself grant any immigration status and does not guarantee that the alien beneficiary will subsequently be found to be eligible for a visa, for admission to the United States, or for an extension, change, or adjustment of status.
