What the Official Notice Said

The above petition has been approved. We have sent it to the Department of State National Visa Center (NVC) 32 Colchester Avenue, Portsmouth, NH 03801-2909. NVC processes all approved immigrant visa petitions that need consular action. It also determines which consular post is the appropriate consulate to complete visa processing. The NVC will then forward the approved petition to that consulate.
