The above petition for an NATIONAL INTEREST WAIVER-PHYSICIAN (NIW-PHYSICIAN) has been approved. We have sent it to the Department of State National Visa Center (NVC), 32 Rochester Avenue, Portsmouth, NH 03801-2909. NVC processes all approved immigrant visa petitions that need consular action. It also determines which consular post is the appropriate consulate to complete visa processing. The NVC will then forward the approved petition to that consulate.

This completes all USCIS action on this petition. You should allow a minimum of 30 days for Department of State processing before contacting the NVC. If you have not received any correspondence from the NVC within 30 days, you may contact the NVC by e-mail at NVCINQUIRY@state.gov. You will need to enter the USCIS receipt number from this approval notice in the subject line. In order to receive information about your petition, you will need to include the Petitioner's name and date of birth, and the Applicant's name and date of birth, in the body of the e-mail.

Pursuant to Section 203(b)(2) of the Immigration and Nationality Act (INA), the beneficiary is not eligible for issuance of an immigrant visa until he/she completes 3 or 5 (whichever is applicable) years of employment in an underserved area.

The NVC will contact the person for whom you are petitioning concerning further immigrant visa processing steps. The approval of this visa petition does not constitute an immigration status and does not guarantee that the alien beneficiary will subsequently be found to be eligible for a visa, for admission to the United States, or for an extension, change, or adjustment of status.
