The above petition for a NATIONAL INTEREST WAIVER-PHYSICIAN (NIW PHYSICIAN) has been approved. If the person for whom you are petitioning is or becomes eligible to apply for adjustment of status, he or she should submit a copy of this notice with Form I-485, Application to Register Permanent Residence or Adjust Status, with appropriate fee to this Service Center. Additional information about eligibility for adjustment of status may be obtained from the local USCIS office serving the area where he or she lives, or by calling 1-800-375-5283. He or she should contact the local USCIS office to obtain Form I-485, Application to Register Permanent Residence or Adjust Status.

The approval of this visa petition does not itself grant any immigration status and does not guarantee that the beneficiary will subsequently be found to be eligible for a visa, for admission to the United States, or for an extension, change, or adjustment of status.
