The above petition has been approved. The petition indicates that the person for whom you are petitioning is in the United States and will apply for adjustment of status. If the person for whom you are petitioning decides to apply for a visa outside the United States based upon this petition, the petitioner should file Form I-824, Application for Action on an Approved Application or Petition, to request that we send the petition to the Department of State National Visa Center (NVC).

The NVC processes all approved immigrant visa petitions that require consular action. The NVC also determines which consular post is the appropriate consulate to complete visa processing. The NVC will then forward the approved petition to that consulate.

The approval of this visa petition does not grant immigration status. The petitioner must be eligible to subsequently apply to be eligible for a visa, for admission to the United States, or for an extension, change, or adjustment of status.
